Joint tax returns may not exceed \$400 tax credit. Individual tax returns may not exceed \$200 tax credit. Corporate and business checks are not eligible. Recreational, amusement, and tourist field trips are not eligible. This process allows donors to receive money back through a tax credit upon filing their returns. There are NO REFUNDS for ANY reason.
